For International Students: photocopy of International Passport and any other 'Pass' held in Singapore (if any).
 - Photocopy of NRIC and/or International Passport of both Parents and Legal Guardian (if any).
- * Certified means witnessed by a member of staff or approved agent of Insworld, the school that issued the transcript or a 3rd party with the legal power to certify documents in your country. All students must produce the originals of these documents for verification before commencing their studies at Insworld.

Note: Additional documents may be required from students who need to apply for a Student's Pass (i.e., birth certificate, financial statements, etc. as required by the Immigration & Checkpoint Authority of Singapore).
